RESOLUTION FIN 78-25: CONTRACT AWARD - SCIENCE ROOM RENOVATIONS AT BUTLER HIGH SCHOOL*

WHEREAS, a recommendation was made by the Superintendent to the **Butler Board of Education** ("Board") to seek a single overall contract for Science Room Renovations at Butler High School (hereinafter the "Project"); and

WHEREAS, the project was properly advertised to prospective bidders in accordance with N.J.S.A. 18A:18A-4; and any applicable SDA regulations; and

WHEREAS, on Wednesday, March 12, 2025, the Board received the following lowest bids from potential bidders in accordance with N.J.S.A. 18A:18A-1, et seq.; and

WHEREAS, upon review of the bid submitted by the apparent low bidder, Wallkill Group, Inc., together with the Bid Specifications and N.J.S.A 18A:18A-1 et seq. For the Project, the Board has determined that the bid submitted by Wallkill Group, Inc. contains a material, non-waivable defect and thus must be rejected as unresponsive; and

WHEREAS, the Board reviewed the bid submitted by the second lowest bidder, Academy Construction, Inc, and finds same responsive to the Bid Specifications, SDA regulations, and New Jersey Contract Law, N.J.S.A. 18A:18A-1 et seq.; and

NOW, THEREFORE:

BE IT RESOLVED, that the Board hereby awards the Project to Academy Construction, Inc. as the lowest responsible bidder at the total amount of \$794,000.00 which includes an allowance for unforeseen conditions of \$50,00.00 included in the Base Bid.
